Terms and Conditions

THE DIRECT CUSTOMER PROGRAM: Direct Customers may order their products directly from the Company. There are no minimum purchase requirements to remain an active Direct Customer.

THE PREFERRED CUSTOMER PROGRAM: The Preferred Customer program allows customers the opportunity to purchase Kyäni products with up to a 10% discount off of the retail price so long as the Preferred Customer has a minimum Autoship Order of \$64PV each month. Your Custom Preferred Customer Order will automatically be sent to you each month regardless of any other purchases you may have made during the month. You may change the order anytime up to ten days before your Autoship Date.

Kyäni AUTOSHIP TERMS & CONDITIONS

By completing the Autoship information on the front of this Agreement, I authorize Kyäni to ship the product package I have selected each month. Kyäni is under no obligation to ship products if the authorized credit card(s) have been closed or the monthly limit exceeded. Kyäni reserves the right to modify or terminate the Autoship programs in its sole discretion.

PAYMENT AUTHORIZATION: I authorize Kyäni to withdraw payment for my Direct and/or Preferred Customer order(s) from my credit card identified on the front of this Agreement. Kyäni's authorized to withdraw payment equal only to the amount of the products, applicable sales tax, and shipping and handling of products that I order, or the Auto Order Customer orders I have selected. I agree to pay a \$20.00 service fee in the event a check or charge is returned for any reason. I have the right to have the amount of any erroneous withdrawal deposited into my account as soon as reasonably possible and upon proper notification to Kyäni. I shall hold Kyäni harmless for all special or consequential damages, whether direct or indirect, resulting from any wrongful debit to my account.

CHANGES: To change your Custom Preferred Customer order selections, method of payments, or the authorized amount, you may go online and login to your Customer Account and make the desired changes; or you may call Kyäni Customer Service and ask for the desired changes to be made to your Custom Autoship Order. Kyäni reserves the right to change its prices associated with its products without notice.

TERM: This Agreement will remain in effect until you: (1) go online and cancel or change your status as a Preferred Customer with Kyäni. (2) **send, in writing, your cancellation of this Agreement to Kyäni, Inc., at 1070 River Walk Dr. Suite 350, Idaho Falls, Idaho 83402, or by fax to (208) 529-9873** (Notice must include your signature, printed name, address, and Preferred Customer Number), or (3) stop payment of any withdrawals by Kyäni by notifying your issuing bank at least three days prior to the scheduled charging of your account. Notice of cancellation must be received no later than 10 days before your Autoship Date in order to avoid charges for that month. If a cancellation notice is received after ten days before your Autoship Date for the current month, cancellation will become effective in the month following the month in which your notice of cancellation is received by Kyäni.
